I. Agenda

III. Action Items

1. Fee Policy 2021-2022

Mr. Jacob Smith spoke on the fee policy. With the COVID 19 pandemic IDLA was awarded one-time federal funding last year which enabled IDLA to offer reduced fees. That funding has been expended and we now need to revert back to the previous fee structure in place prior to the pandemic. Elementary fees have also been included in the new fee policy moving forward. A motion to restore or go back to the prior fee structure pre -COVID 19 was made by Dr. Brady Dickinson and seconded by Mr. Steve Henson. The motion is unanimous.

IV. Updates

1. Board Member Updates - All

All Board members gave updates to the status and current operations in their respective districts and industries. Mr. Cirka announced that he will be retiring as Superintendent at the end of this school year in June. A Superintendent search is currently underway.

Dr. Charlton spoke about Mr. Will Goodman's replacement as Director of District Services. Mr. Ryan Cantrell will be joining IDLA July 1st, 2021. He is currently the Superintendent of Bruneau -Grandview SD and has sat on the Governor's Task Force for rural community districts.

2. Legislative Update

Dr. Cheryl Charlton talked about the current Legislative session, it is still going on and how there have been some very interesting decisions made. With budgets still being discussed and not yet set Dr. Charlton is hopeful that there are no items to harm funding for students and districts. Dr. Charlton still sits on the Governor's Emergency Council as well.

3. IREA

As the Idaho state affiliate for the NREA the IREA was created. Mr. Jeff Farden has been instrumental in getting this going. Mr. Farden talked about the IREA just being launched last fall (2020). A symposium was held which allowed collaboration with Superintendents around the state to determine the greatest needs. The function of the IREA is to bridge the gap and provide the support and network that is missing. The IREA is intending to utilize current resources as a funnel for direction. Monthly webinars are being held with changing Keynote speakers.

4. June Board Meeting, Tuesday, June 8, 2021

Dr. Charlton asked if the Board is comfortable having a face to face end of year meeting. The Board members are in agreement. Arrangements will be made and further information will be forthcoming.
