# IV. Updates

- 1. Compensation Analysis Mr. Brian Smith
  - Mr. Brian Smith reported that the company, 3 C's has been hired to perform a compensation audit analysis. The initial phase has begun. A large part of the IDLA full-time staff has been with the organization for 10-15 years. The study will be a mixture of local and national organizations. State agencies, virtual schools, and industry-specific companies will be compared.
- 2. IDLA Website Mr. Brian Smith
  - Mr. Brian Smith provided an update on the status of the website project. S360 was hired to audit the current website and provide information on how to improve upon it. The most significant finding was related to individuals that are color blind. There have been many changes made to fix those barriers. IDLA ended up selecting Brand Craft to redo the website. This will take several months of work before a new version is up and running.
- 3. Personnel Mr. Jeff Simmons
  - Mr. Jeff Simmons spoke about the leadership position currently open and posted. It will be a combination of the Regional Coordinator job description and overseeing the Regional Coordinator team. The candidate will have prior experience working in a school or a district. They will be required to attend the Strategic Leadership Team meetings. Also, currently recruiting part-time teachers and principals.
- 4. Legislative Session Mr. Jeff Simmons
  - Mr. Jeff Simmons updated the Board on the legislative session regarding IDLA. We are currently waiting to see how the budgeting process goes. Contact has been made with the legislators that may be working on it on the committee. Idaho is ranked 3<sup>rd</sup> in the nation from heritage on school choice and education freedom. Open enrollment is getting some attention from legislators.
- 5. June 13<sup>th</sup>, 2023 Board Meeting Date Mr. Jeff Simmons Mr. Jeff Simmons polled the board members to change the date to June 15th potentially. This did not work in favor of most of the board. The decision is to keep the original date of June 13<sup>th</sup>.
