Board Member Round Robin Updates – All
 Each Board member gave updates as to their respective regions, districts, and industry. Districts are in the home stretch of end of year with students preparing for graduation as well as working through budgets

and contract negotiations. Our industry partner reported that the business has been acquired by another company and the acquisition is going well. Dr Joel Wilson is wrapping up his first year with the State Department of Education.

  Mrs. Valerie Doherty provided the Board with an update on the current status of marketing and communication goals and the work being done with Strategies 360 on a website redesign.
- 4. Facility update Mr. Brian Smith Mr. Brian Smith continues to work with Boise School District on plans for the office. The most recent plan is to not move forward with construction and simply share the office space. This will be a savings of \$75,000 a year. There are also plans to release the office space currently leased at Idaho Association of School Administrators. This will be a savings of \$22,000 a year.
